Parking regulations are enforced and a valid CampusParc permit or paid hourly parking is required at all times.

Restricted Spaces

ADA accessible, state vehicle, and reserved spaces are restricted to authorized vehicles only. Unauthorized vehicles are subject to citation and relocation at the owner's expense.

Loading zones are signed with a posted time limit to provide access for deliveries or immediate pick-up and drop-off of passengers.

Paid hourly parking is required for vehicles parked in marked hourly spaces, at single-space meters, or in parking garages.

Motorcycle Parking

Motorcycles must be parked in two-wheel vehicle spaces during peak periods and may park in unrestricted four-wheel spaces during off-peak periods.

Overnight and Extended Parking

Vehicles parked for more than 72 consecutive hours are subject to citation or impoundment.
