### Permit Access

Keycards provide garage access to applicable permits during the times and at garages outlined in this table.

Garage gates are activated by scanning the QR code on the back of the keycard at readers located at garage entrances and exits.

Keycards may be used to exit only if the last use was for entry, and vice versa. If a ticket is pulled to enter a garage, payment must be made at exit.

#### **Visitor Garages**

The 11th Avenue, 12th Avenue and Wexner Medical Center garages are dedicated to visitors 5 a.m. - 4 p.m. weekdays. Permit holders exiting garages after 8 a.m. weekdays may be subject to additional fees.

SAFEAUTO and the James Outpatient Care Garages are dedicated to visitors at all times.

#### **Motorcycle Parking**

Motorcycles may be parked in the following garages with dedicated motorcycle entrances: SAFEAUTO, 9th Avenue East, Ohio Union South, Neil Avenue, Arps, Lane Avenue, West Lane Avenue garages, and Wexner Medical Center garages...


## Mandated Stay Wexner Medical Center

Overnight medical center staff required to stay past their garage access time for patient care will be able to scan out of garages normally.

#### **Long-Term Overnight Garage Parking**

Long-term (more than 72 consecutive hours) overnight permit parking in the following garages is restricted to the following designated levels:

- 11th Avenue Garage: Levels 3 and above
- Arps Garage: Levels 4 and above
- Gateway Garage: Levels 4 and above
- Lane Avenue Garage: Levels 5 and above
- Ohio Union North Garage: Levels 4S and above
- West Lane Avenue Garage: No Restrictions
